

## MANAGED ACCOUNT AGREEMENT 管理帳戶協議書

I hereby constitute and appoint Astrum Capital Management Limited as my agent and attorneyin-fact to buy, sell (including short sales) and to trade in any and all kinds of securities including, but not limited to, shares, stocks warrants, options, bonds, debentures, notes, bills of exchange, certificates and commercial paper of any description whatsoever and wheresoever issued, dealt in or located, or otherwise, in accordance with the practices and procedures of Astrum Capital Management Limited for my account and risk and in my name, it being understood that any such transaction may be effected with Astrum Capital Management Limited as an agent. I hereby agree to pay Astrum Capital Management Limited a management fee of 1.5% p.a. of equity (market value+cash), such fees shall accrue daily and charge to my account monthly at the end of each month and a 20% Performance Fees in according to the appreciation of the equity in my account, charge monthly at the end of each month. The Performance Fees shall be calculated as per the attached appendix 1. I hereby also agree the redemption of my managed account could be effected by either the fund manager or his successors or myself by giving 14 days notice in writing. Under such circumstances, the management fee will be charged on a pro-rata basis without any other penalty, minimum period and back-end load.

本人在此構成,並任命阿仕特朗資本管理有限公司為我的代理人和法定委託人進行購買,出售(包括 賣空)及買賣任何及各類證券,包括但不限於任何種類及任何地點的發行,或位於處理之股票,股票 認股權證,期權,債券,公司債券,票據,匯票,證書及商業票據,或其他,全按照以本人的名字在 阿仕特朗資本管理有限公司開設的帳戶和風險慣例和程序處理,此一切經由阿仕特朗資本管理有限公 司進行之交易,均以代理人身份行事。本人在此同意向阿仕特朗資本管理有限公司支付管理費,計為 資產値(市値+現金)之1.5%年利率。該費用應每日累計並在月結日於本人帳戶內扣除及 20%表現費以根 據帳戶資產値增長部份計算亦同時在月結日扣除。表現費計算方式將依據附表一進行。本人在此亦同 意本人帳戶可憑本人、基金經理或其繼承人的 14 天書面通知即可贖回,在此情況下,管理費將按比例 扣除而無繳付其他罰款、最底期限及終止帳戶費用。

In all such transactions, Astrum Capital Management Limited is authorized to act for me and on my behalf in the same manner and with the same force and effect as I might or could do with respect to such transactions, as well as with respect to all other things necessary or incidental to the furtherance or conduct of such transactions made for my account.

This authorization and indemnity is in addition to (any in no way limits or restricts) any rights which Astrum Capital Management Limited may have under any other agreement or agreement between me and Astrum Capital Management Limited.

This authorization and indemnity will remain in full force, unless sooner revoked, and such revocation shall be in writing signed by me and addressed and delivered to the office of Astrum Capital Management Limited with which I regularly communicate and shall be effective when received by such office, but such revocation shall not affect any liability in any way resulting from transactions initiated prior to such revocation. This authorization and indemnity shall ensure to the benefit of Astrum Capital Management Limited, its successors, by merger, consolidation or otherwise, and assigns.

For the avoidance of doubt, I hereby admit and acknowledge that my said agent and attorney-infact has never held himself/itself out to me as an investment expert in Securities of any kind and I further admit and acknowledge that the associated risks in such appointment has been clearly and distinctively explained to me by my agent and attorney-in-fact.
