The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 21 October 2021 confirming the registration of the new English name “RaffAello-Astrum Financial Holdings Limited” and the dispensation of its Chinese name “阿仕特朗金融控股有限公司” in Hong Kong under Part 16 of the Companies Ordinance.

CHANGE OF COMPANY WEBSITE

Pursuant to the approval by the Independent Shareholders at the EGM on 23 September 2021, the Board is pleased to announce that the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in the Cayman Islands on 28 September 2021 certifying the change of English name of the Company from “Astrum Financial Holdings Limited” to “RaffAello-Astrum Financial Holdings Limited” and the dispensation of the dual foreign name in Chinese of the Company, being “阿仕特朗金融控股有限公司”. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 21 October 2021 confirming the registration of the new English name “RaffAello-Astrum Financial Holdings Limited” and the dispensation of its Chinese name “阿仕特朗金融控股有限公司” in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF COMPANY WEBSITE

CHANGE OF STOCK SHORT NAME
